What is the Scorecard all about?

We sent out the WHERE DO YOU STAND Survey to 43 candidates running for a seat in the 2022 Victorian State Election. All of these candidates are standing in the Goulburn Valley or north-east Victorian regions. We asked them 10 questions about gender equality and health equity policy.



11 candidates completed the survey. They represented the Australian Greens, the Animal Justice Party, Health Australia, Derryn Hinch's Justice Party and one Independent:

Who didn't answer?

We received no response from any candidates representing: the Australian Labor Party; the Nationals; Shooters, Fishers and Farmers; Victorian Socialists; Family First; Freedom Party; One Nation; Sustainable Australia; Australia United; or any Independents not mentioned above. We received a commitment to pass the survey to the Shadow Minister for Women from a representative of the Victorian Liberals, although the timeframe for a response has passed without further contact.
